**AN ORDINANCE TO RE-PRECINCT PAGE COUNTY AND**  
**ADJUST VOTING PRECINCT BOUNDARIES**

**(REPLACES ORDINANCE NO. 2001-1)**

BE IT ENACTED BY THE PAGE COUNTY BOARD OF SUPERVISORS:

SECTION 1. Purpose. The purpose of this ordinance is to re-precinct Page County in this year following the Federal Decennial Census as required by Section 49.7, Code of Iowa.

SECTION 2. Division into Precincts. The County of Page shall be divided into eleven (11) precincts plus the Absentee Precinct. The number of precincts, precinct name, precinct population, and legal descriptions are described below:
