ORDINANCE 2004-1: AN ORDINANCE REGULATING SEXUALLY ORIENTED BUSINESSES, REQUIRING LICENSES, REGULATING THE LOCATIONS THEREOF AND PROVIDING PENALTIES FOR VIOLATION

DECLARATION OF INTENT

It is the purpose of this ordinance to regulate sexually oriented businesses to promote the health, safety, morals and general welfare of the citizens of the county, and to establish reasonable and uniform regulations to prevent the continued deleterious location and concentration of sexually oriented businesses within the county. The provisions of this ordinance have neither the purpose nor effect of imposing a limitation or restriction on the content of any communicative materials, including sexually oriented materials. Similarly, it is not the intent nor effect of this ordinance to restrict or deny access by adults to sexually oriented materials protected by the First Amendment, or to deny access by the distributors and exhibitors of sexually oriented entertainment to their intended market. Neither is the intent nor effect of this ordinance to condone or legitimize the distribution of obscene material.

Charlie Spencer, Conservation Board chairman, met with the Board to again discuss the proposal from the conservation board to purchase about 250 acres currently owned by Sterling McLaren, which includes the quarry. County Attorney Dick Davidson, County Assessor Peggy Smith, and Ray Bryant, county employee and Shenandoah city councilman, were in attendance. Davidson reviewed the contract provided earlier. He suggested that an unconditional purchase agreement is not a good idea; it should be conditional on securing of grants. Smith talked about the exemption issue and parts of the property being taxable because of being rented. Bryant said the Shenandoah City Council will be discussing this proposal tonight. Anderson asked why the City of Shenandoah didn't make a park out of this, and Spencer stated that he was on the county conservation board, and not involved in the city. Armstrong asked about the amenities that would be demanded by park users, and Spencer stated there would be no flush toilets or anything like that. Anderson stated he was totally opposed to this as long as the Natural Heritage Foundation is involved.

Spencer stated that he approached the Iowa Natural Heritage Foundation for assistance with this because the conservation board has received help from them in the past. Davidson stated that the conservation board has done good work for the County.

Armstrong stated this is a bad time for this issue to come up because of having to say no to some really good things during the budget process, and at this time, she would have to say no to this. Davidson suggests that the Board wait until they hear from the Conservation Board after they have met with the City of Shenandoah tonight.

Bryant asked if the conservation board is asking for additional money in the next year or two to do this, and Spencer said no. It is estimated that this property will take between one and five hours per week maintenance.

Anderson stated there were three ways he would consider this: get the price down, take Natural Heritage out of the picture, and work on a budget for maintenance. Armstrong agreed with this.

Spencer said the conservation board is not asking for anything from the Board except the approval to pursue it. Armstrong wants no county responsibility or liability with this.

Richardson suggested the issue be tabled until the Conservation Board meets with the City of Shenandoah and the Conservation Board makes some decisions.

The Sheriff's Report of Fees for February was received and filed.

The following resolution is the same as one passed in 2000, with a change in the name of the Board Chairperson. On a motion by Richardson, seconded by Anderson, the following motion was passed unanimously:

There are already 7 park areas owned by Page County. Bitting will do some research on the Board's areas of concern.

Sheriff Mike Williams talked with the Board about the handicapped ramp for the jail. The bids range from \$4200 to \$6600. The Board talked by phone with Ray Bryant, ADA Coordinator, about the proposed ramp at the Sheriff's office. Williams and Bryant will work on this next week.

Williams then talked with the Board about purchasing patrol cars. Through the state bid program, cars are \$16,724 each and pickups are \$22,070. Williams will order the cars today, and they will be delivered around June 30th. Williams feels he can get more money for the old patrol cars if he sells them by sealed bid rather than as trade ins. Weeds, as specified by the Code, are:

- 1. PRIMARY NOXIOUS WEEDS: quack grass, perennial sow thistle, Canada thistle, bull thistle, European morning glory or field bindweed, horse nettle, leafy spurge, perennial pepper-grass, Russian knapweed, buckthorn, and all other species of thistles, shall be controlled.
- 2. SECONDARY NOXIOUS WEEDS: butterprint annual, cocklebur annual, wild mustard annual, wild carrot biennial, buckhorn perennial, sheep sorrel perennial, sour dock perennial, smooth dock perennial, poison hemlock, multiflora rose, wild sunflower annual, puncture vine annual, teasel biennial, and shattercane annual, shall be controlled.
- 3. This resolution shall also pertain to all state and primary roads and railroad right of way.

If the owner or person in control of any real estate fails to comply with the foregoing order, the Weed Commissioner shall cause this to be done and the expense of said work including costs of serving notice and other costs, if any, shall be taxed against the real estate on which the noxious weeds are destroyed.

The County Auditor is hereby directed to cause notice of the making and entering of the foregoing order to be published once in each of the official newspapers of the County.

WHEREAS, counties enforce the criminal laws passed by the State of Iowa, provide the county attorneys who prosecute criminals, and even provide the courtrooms where the criminal cases are tried, but do not receive any of the criminal fine money, which all goes to the State of Iowa; and

WHEREAS, in an attempt to begin to address this inequity the 2004 lowa Legislature passed House File 2569, which provides that if a court imposes a fine or forfeiture for any simple misdemeanor punishable as a scheduled violation pursuant to a citation issued by the sheriff. the court shall assess a five dollar county enforcement surcharge for each applicable violation, with the surcharge going to the county general fund of the county where the citation was issued;

As a result of various deficiencies at the Clarinda Water Treatment Plant, a source of water for Page 1 Rural Water District, the county has planned a water treatment improvement project. The City of Clarinda has hired Fox Engineering Associates to complete a Preliminary Engineering Plan and cost estimate. The engineer proposes to construct a treatment plant with conventional sedimentation and filtration.

The improvements will take approximately 2 years to complete. The CDBG application will be made on or before December 8, 2004. The project is estimated to cost \$7,347,000. The County is applying for an \$800,000 CDBG grant and Page 1 Rural Water District will provide the local share of \$6,547,000 through USDA-RD grant/loans. The project will benefit the recipients of Page 1 Rural Water in Page County, particularly those who are low-moderate income residents. No persons will be displaced by the proposed activity. Any acquisition of land will occur in accordance with the provisions of the Uniform Acquisition and Relocation Act.
